Notes:

(4): In certain cases, auxiliary or subsidiary company assessed values were combined with parent company assessed values where the Department was aware of the relationship. For example, Sierra Pacific Electric, Sierra Pacific Gas and Nevada Power were combined for purposes of statewide totals. Locally assessed companies are listed as provided by each county assessor and were not combined on the locally-assessed only top ten list. Other companies shown on the Statewide Top Ten list which represent combined entities include Newmont and Barrick. "Newmont" includes Newmont Mining Corporation, Newmont Mining Co (BMGC), Newmont NV Energy Invest LLC, Newmont Gold Company, Newmont Midas Operations Inc., and Newmont. "Barrick" includes Barrick Gold Mines, Barrick Goldstrike Mines, Inc. and Barrick Gold of North America.

(5): The Top Ten Statewide list is limited to the blend of centrally-assessed and locally-assessed top ten lists as provided by the Centrally-assessed Section of the Division of Local Government Services and local county assessors. The reader should be aware of the possibility that a taxpayer might not appear on the Top Ten Statewide list because the taxpayer's assessed value in some counties was not listed in the top ten locally-assessed list. For example, Wal-Mart was listed on the Top Ten locally assessed lists in Churchill, Douglas, Humboldt, Storey, and Washoe Counties but the statewide total could not be calculated for the company because the company was not on the Top Ten list for Clark County.

(6): Actual tax liabilities may not have a direct relationship to assessed value due to the "tax cap" pursuant to NRS 361.4722 through 4724. These values are based on information received by the Department as of November 15, 2014, along with the Centrally Assessed Bulletins #198 (Secured) & 197A (Unsecured).
